

CHAPTER 1
ADMINISTRATION AND GOVERNMENT
ARTICLE 1
PLANNING COMMISSION

§1-101. Purpose

The purpose of this Article is to establish and provide for a Planning Commission in the Township of Oakland, Butler County, Pennsylvania.

§1-102. Establishment

The Board of Supervisors shall appoint and maintain a Township Planning Commission in accordance with Article II of the Act of July 31, 1968, the Pennsylvania Municipalities Planning Code, Act No. 247, Section 201 et seq., and the amendments and supplements presently existing and that may hereafter be made, conferring upon said Commission all the powers and authority as outlined in said Act. The Planning Commission shall consist of five (5) members whose term of office shall commence on the day of appointment and whose term shall be for a period of four (4) years. Whenever a vacancy has occurred or is about to occur by reason of the expiration of the term of any member or because the member is no longer serving in the capacity of his original appointment, the Board of Supervisors shall appoint a member for a term of five (5) years from the date of expiration of the prior term to succeed the member whose term has expired or is about to expire or to complete a term which has been only partially fulfilled.

CHAPTER 1
ARTICLE 2
SUPERVISORS COMPENSATION

§ 1-201. Purpose

The purpose of this Article is to provide compensation to the members of the Board of Supervisors of the Township of Oakland, Butler County, Pennsylvania, for the duties imposed by the Second Class Township Code of the Commonwealth of Pennsylvania.

§ 1-202. Amount of Compensation

Each Supervisor of the Township of Oakland shall receive compensation for the duties imposed by the Second Class Township Code in an amount as may be established from time to time by resolution of the Board of Supervisors.

§ 1-203. Payment of Compensation

The compensation provided for in §1-202 shall be paid in monthly or quarterly installments as may be determined by resolution of the Board of Supervisors from time to time.

CHAPTER 1
ARTICLE 3
INTERGOVERNMENTAL COOPERATION

§1-301. General

The Township of Oakland has expressed its intent to cooperate with other near or adjacent communities and municipalities for the joint administration, assumption, delegation and/or transfer of responsibilities with respect to the fulfillment of municipal responsibilities, duties, and services as permitted or required to be performed pursuant to the Second Class Township Code.

§1-302. Agreements

- A. The Township of Oakland hereby authorizes agreements between itself and other near or adjacent communities and municipalities and any other signatory municipalities which provide for the assumption, delegation and/or transfer of responsibilities with respect to the fulfillment of municipal responsibilities, duties, and services as permitted or required to be performed pursuant to the Second Class Township Code. Agreement to enter into any such Intergovernmental Cooperation Agreement shall be evidenced by Resolution of the Board of Supervisors.
- B. The duration of such Agreement(s) shall be indefinite subject to termination as provided in such agreement(s) entered into between the municipality/municipalities.
- C. Any organizational structure necessary to implement such agreement shall be set forth in such agreements.
- D. Each municipality shall be responsible for such expenses incurred by reason of any action taken pursuant to any cooperative agreement as set forth in such cooperative agreement.
- E. All property, real or personal, which may be acquired, manage, licensed, leased or disposed of shall be done pursuant to such joint cooperation agreement.
- F. The municipality shall retain the responsibility for the management, direction and control of its employees except as set forth in any such joint municipal cooperation agreement(s).

§1-303. Effective Date

This Article shall become effective upon the execution of any Agreement and enactment of resolution by each of the municipalities who are or in the future may become parties to cooperative agreements pursuant hereto.
