# CALL MEETING TO ORDER / PLEDGE OF ALLEGIANCE

Supervisor Brian Hans called the meeting to order at 9:03 a.m. and the Pledge of Allegiance was recited.

# APPROVE AGENDA

Supervisor Regis Thoma motioned to approve the Meeting Agenda; Supervisor Brent Patten seconded the motion. ROLL CALL: The motion was approved by all.

# APPROVE MEETING MINUTES

Supervisor Brent Patten motioned to approve the meeting minutes for the month of October; Supervisor Regis Thoma seconded the motion. ROLL CALL: The motion was approved by all.

# APPROVE TREASURER'S REPORT

Lease Contract – The leasing contract for the Township property on Shearer and North Butler Church Road was presented to the Board of Supervisors. Mr. Harkey stated that it was the standard parcels plan for non-surface leasing rights. He stated that there should be no problems with the water on Shearer Road. Royalties and bonuses were included. The Board asked that Nadine Neff forward the contract to our attorney for review.

Hauling Agreement – The Board reviewed the recommendations of Attorney Phil Lope. After some discussion, the Board agreed to go with Phil's recommendations. Supervisor Brent Patten motioned to approve the contract with recommendations; Supervisor Regis Thoma seconded the motion. ROLL CALL: The motion was approved by all.

# CORRESPONDENCE

#### <u>Dawson Geophysical Company – Seismic Survey</u>

A letter was received from Dawson Geophysical regarding some seismic testing to be conducted on Hoon, Thorn Run and Boydstown Roads. The process will involve three trucks. **Supervisor Brent Patten motioned** that they will be required to bond those roads; **Supervisor Brian Hans seconded the motion. ROLL CALL:** The motion was approved by all.

<u>URS Corporation - Galli Pad</u> - The Township was notified by URS Corporation, engineers for Shell Appalachia, that a gas well will be constructed in Oakland Township off Center Drive on property owned by Galli.

<u>Farmers National Bank – Check Signatures</u> – Correspondence was received from Farmers that with the automated processing equipment, checks requiring two signatures and having only one signature on it, could potentially be processed without any liability on their part.
